

CHAPTER I

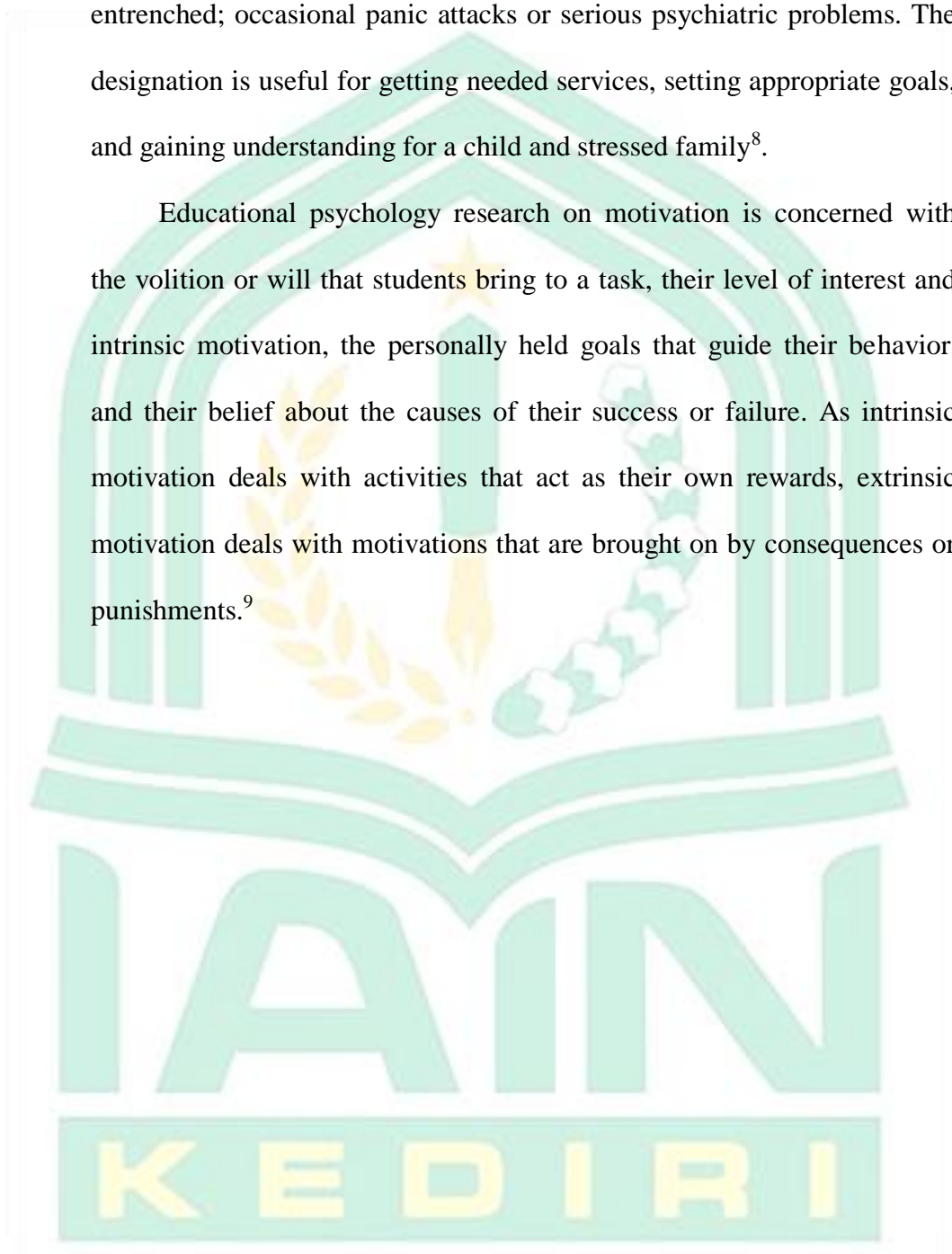
3. Students with special need
