### CHAPTER I

## **INTRODUCTION**

## A. Research Background

Finding Forresteris a movie by Mike Rich which was published in 2000. This film tells about the life of a black man who comes from the Bronx, U.S. named Jamal as a minority in his school. He faced an incident of treatment in the United States. The movie Finding Forrester tells how the act of caring happened. A figure that represents people who are victims of racial concern is Jamal Wallace. Jamal Wallacer is of African-American descent. Jamal and several of his black friends felt the same way. Various acts of injustice and painful treatment are received in their lives. Jamal expressed his feelings about the unfair treatment of the people around him in his novel A Season of Faith's Perfection. A Season of Faith's Perfection is a diary written by Jamal addressed to Mr. Crowford and Mr. Forrester that inspired the sale of rights. Jamal wrote the novel to get answers for the acts of racial concern that befell him.

Movie Finding Forrester presents some interesting story plots to review. One of them is how a student treats her teacher as he should when there is no injustice. This film also presents the true story of racial depiction in modern life and various responses in the struggle of black people against racial treatment. Discriminatory actions are still often carried out, both individually and institutionally. Therefore it is important to discuss current racial events, intended to gain valuable lessons about the importance of respecting others despite their different traits and bodies.

Several reasons the researcher chose the object of research with a literary work in a movie entitled Finding Forrester. First, the film is adapted from a true story. It has awards, such as winning the Dallas-Fort Worth Film Critics Association Awards at the New York Times Bestseller! In 2001, the

award for writers received the Lincoln Prize. This film is a literary award initiated by schools, libraries and education in Illinois, USA. The second is the Movie Finding Forrester, which tells how black people are discriminated against, and everything is told in a diary by a teenager named Jamal Wallace. In addition, this movie means that the fact is that until now the public does not care and only thinks that black people are troublemakers and criminals who sooner or later will end up living in prison. The third is to see how some of the characters are affected by racial hatred and can survive the struggle against deep-rooted assumptions.

Most of the previous studies have discussed discrimination or some of them have discussed racial discrimination. However, there are no researchers who have discussed objects with similar studies from these previous studies.
