CHAPTER I

INTRODUCTION

A. Background of study

Example, Theme and New in English (Davies 1989, 1992; Halliday 1994)², Cohesion will be reconsidered in relation to texture. Texture is one aspect of the study of coherence, which can be thought as the process whereby a reading position is naturalized by texts for listener/readers. Alongside texture, this process involves understandings and expectations about the social context a text dynamically construes.

Cohesion has device to be two points. Those are grammatical cohesion and lexical cohesion, but this research just focused on the first point that is
