ABSTRACT

Key words: discourse markers, types of discourse markers, function of discourse markers.

This research focuses on analyzing utterances in Lauren Weisberger's *The Devil Wears Prada* using Schiffriin's theory. Discourse markers in daily conversation have role that hard to lose. Beside as conjunction in some idea with another idea, discourse markers also have function as fill inanition in some speech so the hearer still consistent with the speaker said. For the speaker, discourse markers make an easy to extend something in different topic in one speech. The purpose of the study are to know the types of discourse markers used in the novel of Lauren Weisberger's novel entitled *The Devil Wears Prada* and to know how the discourse markers are used in Lauren Weisberger's novel entitled *The Devil Wears Prada*.

The research design of this study is descriptive qualitative research and the researcher used Schiffriin's theory to analyze the data. The data sources are the utterances in the form of word, phrases or sentences taken from the novel. Then, the researcher analysis the types of discourse marker based on Schiffriin's theory. Finally, the researcher analyzes the function of discourse markers.

This study, found that there are six types of discourse markers used in the novel. Those are Marker of Information Management (3 utterances), Marker of Response (2 utterances), Discourse Connectives (7 utterances), Markers of Cause and results (5 utterances), Marker of Temporal Adverb (5 utterances), and the last Markers of information (6 utterances). So, the totally are 29 utterances. And each of discourse marker type has a function. Those are Marker of information management (2 functions), marker of response (3 functions), discourse connective (3 functions), marker of cause and result (2 functions), marker of temporal adverb (3 functions, markers of information management (2 functions). So, the novel uses all the types of discourse markers but not all utterances use all the function the function from discourse markers. Finally, it is suggested that the next researcher can study discourse markers more complete by using different subject and theory.
