CHAPTER I

INTRODUCTION

This chapter presents background of the study, problem of the study, objectives of the study, scope and limitation of the study, significance of the study, and definition of key terms.

A. The Background of the Study.

This research wants to know the relation between Arabic and English. The researcher focuses on students' ability in Arabic pronunciation and English pronunciation. *Al Qur'an* is a guideline for Muslims and written in Arabic characters. As Islamic students, we have to be able to read Al Quran as well as possible. To read *Al Qur'an*, Muslims have to know the knowledge of Arabic pronunciation. Arabic pronunciation is places to produce Arabic characters¹. Not only to read Al Qur'an but also to pronounce Arabic, we have to apply the knowledge of Arabic pronunciation. While in English, there is English phonology that is the systematic study of pronunciation that English learners have to learn.
