B. Research Question

C. Research Objectives

D. Hypotheses

Based on the research objectives, the researcher wants to know the effectiveness of using E-Flipbook learning media in increasing the reading skills of MAN 4 Kediri students. The researcher formed a hypothesis for this study. There are two hypotheses, namely H₀ and H₁. The explanation of the hypothesis is as follows:

H₀ : There is no significant difference in reading ability between students taught using E-Flipbook media and students taught using printed book.

H₁ : There is a significant difference in reading ability between students taught using e-flipbook media and students taught using printed book.

E. Scope and Limitation

The scope of the problem is important to avoid misunderstandings. The issue at hand in this study is restricted to understanding how utilizing e-flipbooks has affected learning and how using them has enhanced readers' comprehension of narrative texts.

1. Effectiveness

2. E-Flip Book

3. Reading

Reading is the process of oral pronunciation to understand the content that is contained in the reading, according to Nurhadi in Reading Fast and Effective (1987).

4. Narrative Text

"A succession of events might be referred to as a narrative. Its fundamental elements are the events' chronological order (the story), how those events are

expressed (in text or images), and how those events are described (the narration), according to Nielsen (2008).
