

CHAPTER V

A. Conclusion

Based on the results of the analysis that has been carried out, several conclusions are obtained as follows:

1. The value of brotherhood in *the tafsir al-Munir* by Wahbah az-Zuhaili, towards the interpretation of surah Yusuf, is shown through the attitude of the Prophet Yusuf who shows compassion, sincerity, patience, and the ability to forgive despite having experienced betrayal from his brothers. This attitude reflects the teachings of Islāmiyyah ukhuwah which is based on faith and piety, and upholds peace and forgiveness as a way to maintain harmony in fraternal relations. Meanwhile, in *Lontar Yusup Banyuwangi*, the values of brotherhood are displayed with a local literary approach that touches on the emotional and humanistic side. The figure of Yusuf is described as still having deep affection for his brothers even though he has been betrayed, as depicted in the verses of pupuh kasmaran which shows loyalty, empathy, and longing for brothers. Thus, both the *tafsir al-Munir* and *Lontar Yusup* both emphasize the importance of rebuilding the bond of brotherhood based on affection and sincerity.
2. There are several points of similarity and differences between the values of brotherhood contained in the *tafsir al-Munir* Surah Yusuf and in *Lontar Yusup Banyuwangi*. The similarity lies in the emphasis of both sources on the importance of maintaining the harmony of family relationships, forgiving, and re-strengthening fraternal bonds after experiencing conflicts. Both sources display the values of compassion, sincerity,

empathy, and sacrifice as the foundation in fostering healthy brotherly relationships. The difference lies in the approach and perspective used. *Tafsir al-Munir* conveys the values of brotherhood in a spiritual-religious context that is rooted in normative Islamic teachings. Meanwhile, *Lontar Yusup* conveyed these values in the form of a cultural narrative that is more humanistic, emotional, and rooted in the traditions of the local community of Banyuwangi. Thus, the two sources complement each other in describing fraternal values from two distinct but essentially harmonious perspectives.

B. Suggestion

The following authors present some suggestions for further research:

1. For Academics and Researchers Further

To deepen the study of the relationship between the literary texts of the archipelago and the books of tafsir, especially in the perspective of philology and Islamic studies. Similar research can be carried out by analyzing other manuscripts from various regions to enrich scientific treasures.

2. For the general public

It is hoped that the values of brotherhood found in the explanation of the book of tafsir and *Lontar Yusuf Banyuwangi* can be applied in daily life, especially in strengthening social and cultural relations. The preservation of local manuscripts such as *Lontar Yusup* needs to be supported, so that it remains a source of learning for future generations.
