CHAPTER V

CONCLUSION AND SUGGESTIONS

This chapter is divided into two parts, conclusions, and suggestions. In conclusion, the author presents some conclusions concerning the result of the study discussed in the previous chapter. This chapter also gives some suggestions, which contains the views and suggestions of researchers for readers and future researchers.

A. Conclusion

After observing and discussing the results of the study, the following conclusions are obtained.

First, The configuration of mother's ways educate her son were very interesting, when its had been seen the condition of place where they lived. interesting things can be seen when Ma can make a small room where they are locked into a place to play, a place to learn, imagine interacting with the outside world and so on. he is able to bring Jack's imagination into the outside world through role playing games, such as hiking. all the games taught by Ma to Jack are very educative and effective for Jack's development, both psychosocial, cognitive and moral development. In addition, the parenting style is given by Ma to her child, Jack, based on the theory of Diana Baumrind is authoritative,. Ma monitor and impart clear standards for her child's conduct. Ma is assertive, but not intrusive and restrictive. Her disciplinary methods are supportive, rather than punitive. Ma wants her child to be assertive as well as socially responsible, and self-regulated as well as cooperative. Second, the effects of the mother's ways to educate her child are grouped into three groups based on the theory of child development, those are psychosocial development, cognitive development and moral development. the effect of mother's teachings is very influential on Jack's development, Jack grows normally like other children even though his environment is very limited. based on several theories of psychology, Jack has gone through several developments in which every development there are several stages that must be traversed by each child to be categorized as a normal child, in quotes growing normally in a generally determined time. so it can be concluded that Jack is growing normally.

B. Suggestions

Based on research, discussion, and conclusions about mother's ways educate her son and the effects of her ways in the novel Room written by Emma Donoghue, henceforth some suggestions relating to this research will be put forward.

First, The configuration of mother's ways educate her son in this novel is an obligation that must be done by every parent every day.
