CHAPTER I

INTRODUCTION

This chapter presents the background of the study, problem of the study, objective of the study, significance of the study, the limitation of the research, and definition of key terms.

A. Background of the Study

In education, learning is the process interaction between student with instructors and learning resources in a learning enviroment that includes teachers and students who exchange information about lessons. According to (Smith, 1962) learning is the acquisition of the new behavior or weakening or strengthening of old behavior as the result of experience. Learning as the process whereby an individual changes its behavior as a result of experience. Experiences can be gained from learning because students can get knowledge an skills that are very important for students' life (Clarice, 1996). Based on the definition above, it can be concluded that learning is the acquisition of a new behavior, that occurs as the result of relatively permanent changes and the organism's experience or practice. In order words, understanding learning is a process of interaction between students and teachers to help students get be able study well.
