

## CHAPTER V

### CONCLUSION AND SUGGESTION

This chapter present conclusion and suggestion. The conclusion is drawn based on the formulated research problem and the suggestion is expected to give some information to the next researcher who interesting in conducting a research in same field.

#### A. Conclusion

There were three types of speech: locutionary act, illocutionary act, and perlocutionary act; however, the researcher only looked at the illocutionary act and perlocutionary act in president joe biden's speech. The use of John Searle's principle of note-taking during President in Joe Biden's speech " 1-year anniversary of corona virus" is an illocutionary gesture and the effect of it as perlocutionary acts. In the speech act, there were assertives, directives, expressive, commisive,and declaration. Based on finding and discussion, this study just focused on analyzing speech act in speech act in kinds of communication function in illocutionary act and perlocutionary act contained in the speech of President Joe Biden's speech. The first result of this research were the assertives utterance gets 18 out of 39 tests or 45 %. The directives utterance gets 6 out of 39 or 15 %, The expressive utterance gets 9 out of 39 or 23 %, the commissives utterance gets 5 out of 39 or 13% and the declaration utterance gets 1 out of 39 or 3% in illocutionary act.

The second result of this research is perlocution act that contained in the speech by in Joe Biden's speech " 1-year anniversary of corona virus". Then, the researcer founds 7 perlocutionary act that contained in Joe Biden speech. The researcher found that the speaker expecting something in his speech. When the speaker says "*Look, we know what we need to do to beat this virus*" that excerpts

contain perlocution act that about how the speaker expect the audience to beat the virus. At the result above the researcher conclude that in Joe Biden speech there are some perlocution act found in his speech.

## **B. Suggestion**

The researcher wants to make suggestion for the following parties as follows:

1. For the students' English, it is better to know and understand the illocutionary and perlocutionary act in the speech video. It is Joe Biden's speech regarding the Coronavirus Task for briefing. To master the illocutionary act, an interpretation of the result from the spectator or hearer as the perlocutionary act in the speech, one must not only read it but also comprehend its context and intent. How different each is in the illocutionary act. Moreover, it would be better if the illocutionary and perlocutionary act that must remember not only one.
2. For the other researchers who are interested in discourse, to develop for analyzing the pragmatics in the movie and other video analysis of the linguistic study, not only speech but also the other media as an object such as conversations, movie, a newspaper can also be the object of the other discourse analysis of the linguistic study.
3. Based on this study, the researcher hopes that it will be useful for readers and other researchers in the future improvement of discourse analysis, especially the types of illocutionary and perlocutionary acts used as responses from the hearer in the speech.
