

CHAPTER I

INTRODUCTION

This chapter present the background of the study, the problem of the study, the objective of the study, the significance of the study, the scope and limitation of the study and the definition of key terms

A. Background of the study

The Covid-19 virus or known as Corona virus has been a source of problem in many countries. According to the World Health Organization, the COVID-19 virus is a new type of virus that started to spread out of control in the Wuhan area, Hubei Province, China, in December 2019. Recently, the COVID-19 virus has spread in many countries and caused a universal pandemic, especially in Indonesia. This pandemic gives universal problems in Indonesian citizens, industry, economy, especially in education. Due to this pandemic the Ministry of Education and Culture issued Circular Letters 2 and 3 of 2020, in which it explained ways to prevent the spread of the COVID-19 virus in the educational environment (KEMENDIKBUD, 2020).

Most of school, college, private, etc. have stopped face-to-face teaching and doing social or physical distancing. Consequently, teaching and learning process, especially English learning do at home by using online learning or technology driven learning.

The integration of technology has continuously occurred within every other aspect of our life, for instance, education. According to Mustafa (2015) Using technology in foreign language learning and teaching is useful for both

teachers and students. There is a great tendency among teachers to use technological tools in language learning classrooms. Technology has been used to both help and improve language learning. Technology enables teachers to adapt classroom activities, thus enhancing the language learning process. Technology continues to grow in importance as a tool to help teachers facilitate language learning for their learners (Ahmadi, 2015).

Moreover, according to Kapenieks et.al (2012) the new technologically driven learning approaches seemed to offer a solution to the increased demand a comparatively low initial cost and many countries supported a wide array of E-Learning solution. E-learning is learning which utilizes electronic technologies to access educational curriculum outside traditional classroom and it refers to learning that delivered online. There are several various types of applications of E-learning one of them is Google Classroom (Wijaya, 2016). Classroom of use Google is expected to improve quality and providing assistance in education especially in learning English. Google Classroom is a free application designed to assist students and teachers connect, work together, organize and create assignments, it enables learning to be paperless. It makes teachers simply build groups to share assignments and announcements. It also has some benefits such as paperless, can be accessed anywhere and everywhere as long as there is internet connection and from any devices, to communicate between teachers and students, to give feedback to students, and personalized learning. It has a learning feature that makes teachers create and handle assignments actively and also provide feedback to students.

According to Shaharane et al. (2016), Google Classroom's tools thus show it is effective as an active learning tool. It contributed to the training of online instructors in methods and the designing of educational support programs that allow students to succeed in the online environment. It is timely that Google Classroom's tools should be integrated into the teaching and learning of data mining software, not solely because it is a useful utility tool. In addition, according to Mualim (2019) Google Classroom as one of the development of information technology could be used to deliver materials in addition to the traditional physical classrooms, training students' learning hybridity thus optimizing their learning autonomy. According to M. DiCicco (2016) Google Classroom into social studies instruction resulted in an increase of student vocabulary scores except students' understanding of the content knowledge. Google Classroom may be considered as a program for resources in the classroom for teachers and students.

Moreover, according to Hussaini et al. (2020) Google Classroom enhances the teaching and learning process. It is also reliable, effective and efficient in improving students' access and attentiveness towards learning, activities conducted in Google classroom changes students from passive to active learners. Students can easily track their progress with online assessments in Google Classroom, parents can check and monitor the performances and progress of their children easily and at their convenient time. In the current situation of global Covid-19 pandemic, restricted movement and social distancing, it is recommended that applying Google classroom will assist both students and teachers to connect, work together,

create assignments, grade students and post lecture notes (Hussaini etc al. 2020).

In this research, the researcher wants to conduct a study with the same application that is Google Classroom, but focus on reveal the important digital technology in regards in the learning activities, students' experience in using Google Classroom in their learning English, and students' perceptions about the benefit of Google Classroom in learning English through the students' perceptions toward the use of Google Classroom as an alternative media for English learning at SMAN 6 Kota Kediri, as a caused of covid-19.

Based on the explanation the researcher would like to examine about "students' perceptions toward the use of Google Classroom as media for English learning at SMAN 6 Kediri."

B. Research Problem

Based on the background above, the researcher states the problems of the study as follow:

"What are the Students' perceptions toward the use of Google Classroom as media for English learning at SMAN 6 Kota Kediri?"

C. Objective of the Study
