CHAPTER I

INTRODUCTION

This chapter consist of background of study, research problem of study, object of study, the aim of study, scope and limitation of study, and definition of key term.

1. Background of Study

Speaking is one of English skill as well as reading, listening, also writing. Almost all of people use it as a primarily language to communicate each other in their own communities or the wider world. It means through that learners can communicate with others to achieve certain goals or express their opinions, intentions, hopes and viewpoint orally. Thats way speaking is very essential, moreover speaking English (Mukminatuz Z, 2017). Speaking skill taught in every level of education moreover in the high school. Teaching speaking done by using basic competency to increase the material, manage the learning process and competency indicator for assessment (Hammer, 2007). It is mean that teacher are required to manage the learning activities based on the basic competency, which the students must be able to use language in transactional, interpersonal and functional competencies (Nunan, 2003). 3. Objective of Study

4. Research Hyphothesis

This study wants to know the effectiveness of Video Dubbing in improving the pronunciation of first grade students at Mamba'ul Ma'arif Senior High School Denanyar Jombang.

a. Null Hypothesis (H₀)

There is no difference between students who are taught by using Short Movie Dubbing and those who are taught not using Short Movie Dubbing.

b. Alternative Hypothesis (Ha)

There is difference between students who are taught by using Short Movie Dubbing and those who are taught not using Short Movie Dubbing.

5. The Significance of Study

a) Students

The researcher hopes that this technique, Dubbing Short Movies can be an effective way to learn English especially in speaking. It can helps the students to know how to pronounce the word correctly and become more active and confident in speaking. A good speech will be useful for their future when they communicate with others or in the wider world.

This study wants to help the teacher in teaching and learning. The researcher hopes that this technique can create a comfort and effective learning so that the material can be delivered well and easier to understand.

6. Scope and Limitation of Study

The limitation of the study, the researcher can't request to choose the group of sample and population because the researcher doesn.t have authority to do that.

7. Definition of Key Term

The researcher defines the key term of this study in order to avoid misunderstanding of this study.

a) Speaking

Speaking is a productive skill. This usually refers to the skill of someone to communicate with others to achieve certain goals or express their opinions, intentions, hopes and viewpoint. Speaking is the process of constructing and sharing meaning through the use of oral and written symbols in a variety of contexts. In this study, the focus of speaking skill is the fluency and pronunciation of students' speaking.

b) Pronunciation

Brown in Festri Y (2013) states that microskills in verbal communication is very necessary. In teaching verbal communication, the teacher are not only show the whole material but also the pieces of it. That is same as applying strategy to improve speaking skills. In this study, the researcher focus on sound and spelling and intonation.

c) Short Movie

Short movie is a visual content which shows a certain story. Short movie can also defined as any motion picture which is short enough in running time. In this study, the researcher uses animation movie entitled "Abominable" (2019). This short movie is about 5 minutes with English subtitles. The sound and spelling in this movie's conversation can heard clearly and the speed is bit slow. d) Dubbing

Dubbing is the technique which the original dialogues of movies or television's content are replaced by new sounds or dialogues.
