#### **CHAPTER I**

### INTRODUCTION

## A. Background of the Study

In the world, the existence of language basically cannot be separated from life humans, because language is one of the most important communication mediaeffectives for humans in dealing with the outside world around them. Pragmatics is the study of human communication, specifically the choices speakers make to express their intended meaning and the types of inferences listeners get from an utterance in its context (Allan: 2012). An utterance that contains an action

called a speech act. Speech acts are actions that are carried out with the aim or intent to convey, provide information, or convey the speaker's wishes to the listener through speaking or communicating directly. Communication in human life is very important, communication can encourage people to create new media as a communication tool to facilitate the process of communicating.

According to Searle (Rahardi, 2005: 35-36) speech acts are divided into three components, there are locutionary, illocutionary and perlocutionary. Locutions are speech acts that contain the true meaning of the sentence. Illocutionary is the action taken when saying something. Perlocutionary is the effect that the listener produces in a sentence. The three speech acts are actions to convey and provide information. (Searle: 1974) also develops illocutionary speech acts into five kinds, there are assertive, commissive, directive, expressive, and declarative.

Movie is one of the communication media that is often used for conveying messages. Movie is a series of moving pictures, shown in a cinema, or television, and played by an actress/actor. The presence of this movie is very important and in demand by the public. The reason is because people often use movies to entertain themselves or learn something. In a movie, there must also be speech acts from one player to another. There are various kinds of utterances in the film, such as forbidding,

ordering and asking.

The Father 2020 is a film that tells about an elderly man named Anthony. He lives alone in an apartment in London. His daughter, Anne, had several times hired a nurse to care for and accompany her father. But his father always refused it for various reasons. Anthony insisted that he could take care of himself.

Therefore, the researcher conducted this research with the title "An Analysis of Illocutionary Act in the Main Character Utterances in The Father Movie". In this study, the researcher focused his research on the categories and location act function in the father movie.
