#### CHAPTER I

#### INTRODUCTION

# A. Background of the Study

constantly. In graded readers, new vocabulary and grammatical structures are repeated and recycled for learners so that they become familiar with them (Albay, 2017).

Reading comprehension skill is the act of understanding in reading. it is an intentional, active, interactive process that occurs before, during, and after person reads a particular piece of writing. Two elements that make up the process of reading comprehension are vocabulary knowledge and text comprehension. First, in order to understand the text, the reader must be able to comprehend the vocabulary used in the piece of writing. While the text comprehension is much more complex and varied than vocabulary knowledge.
