CHAPTER I

A. Background of Study

F. Definition of Key Terms

In order to avoid misunderstanding about the meaning of keywords listed in this study, the author will describe what the meaning or meaning of the keyword of this study.

1. Model of Study

A learning model is a plan or a pattern used as a guideline in planning learning in the classroom or learning in tutorials. The learning model refers to the learning approach to be used, including the purpose of teaching the stages in learning activities of the learning environment and classroom management (Fatah, 2014). This is in line with Joyce's opinion that "every model of influence leads us in designing learning to help learners achieve learning goals". Joyce and Weil state that the learning model is the student capital with which the teacher can help students to obtain or obtain information, ideas, skills, ways of thinking, and express their own ideas. In addition they also teach how they learn.

The selection of this model according to Rijalulloh is strongly influenced by the nature of the material to be taught is also influenced by the objectives to be achieved in the teaching and the level of ability of learners. In addition, every learning model always has stages (syntax) that students with teacher guidance (Abdullah, 2017). Between one syntax and another syntax also has differences.

These differences, especially those that take place between the opening and closing of learning, must be understood by the teacher in order for the models to be implemented successfully. Therefore, teacher need to master and apply a variety of teaching skills, in order to achieve diverse learning objectives and learning environments that are characteristic of the school at this time (Dr. Rusman).

In Trianto's view, the learning model has four specific characteristics that are not possessed by strategies, methods, or procedures. These characteristics are 1) logical theoretical rationale compiled by its creators or developers 2) the basis of thinking about what and how students learn learning objectives to be achieved 3)

teaching behavior and what is necessary for the capital to be implemented successfully and 4) the learning environment needed for the learning objectives to be achieved.

Based on the statement above, the learning model is a combination, unification, or combination of learning approaches of learning strategies, learning methods, learning techniques, or procedures and has syntax or stages such as the planning stage, implementation, and evaluation stage. Related to this, the learning model has a broader meaning than the strategy approach of the method or procedure.

2. Covid-19

In early 2020, the world was shocked by the incidence of severe infections with unknown causes, starting from a report from China to the World Health Organization (WHO) of 44 severe pneumonia patients in a region namely Wuhan City, Hubei Province, China, precisely on the last day of 2019 China (AJi, 2020). The initial allegations relate to wet markets selling fish, marine animals and various other animals. On January 10, 2020, the cause began to be identified and obtained a code of ethics, namely the new corona virus.

Another report showed transmission to a Chinese tourist companion visiting Japan along with other evidence of transmission to a patient's home contact outside China from a confirmed patient and went to Wuhan City to his partner in the United States. Human to human transmission has led to an extraordinary increase in the number of cases until at the end of January 2020 there was an increase of 2000 confirmed cases within 24 hours. At the end of January 2020 WHO declared Global Emergency status in this corona virus case and on February 11, 2020 WHO named it COVID-19 (Dennaro, 2020).

Information about this virus is certainly still very limited because many things are still in research and epidemiological data will be very developed as well, for that this review is a review based on limited information summarized with the aim of providing information and it is very likely that there will be changes in policies and other related matters according to the development of research results, epidemiological data and the advancement of diagnosis and therapy.

From the explanation above, it is realized that the Covid-19 outbreak is very affecting the performance of all aspects. Offices, food businesses, tourism, schools, and so on. Covid-19 has a very even impact on all circles, especially for education.
